Kayak & Paddle Board Rental Form and Agreement

Kayaks are available to rent at a cost of \$10 each/day or partial day of rental. Kayaks can be kept overnight for an additional \$10. Total fee for renting a kayak overnight is \$30 and total for a paddle board overnight is \$75, 2 day rental plus overnight rental. Paddle Boards are \$25 per day and includes paddle, life jacket and board leash. Only one open reservation will be allowed per household. The paddle boards are 10.6 feet long and weigh about 26 pounds each. The kayaks are 10.5 feet long and weigh about 42 pounds each. After the completion of one reservation, another will be allowed. **Participants are responsible for the loading, unloading, and transporting the paddle boards and kayaks to and from destination.**

A \$50 refundable security deposit is due at the time of the reservation. The deposit must be made either by check or credit card. Furthermore, I understand that I am personally responsible for the repair or replacement of lost, damaged, or stolen items that I have leased and/or used from the Town of Mansfield. Determination of the reparability of any damaged items is at the sole discretion of The Mansfield Parks and Recreation Department. If the damage/loss exceeds the amount of the security deposit, additional charges must be paid within five (5) working days once notified of charges. Failure to do so may result in suspended usage of facilities and steps may be taken to collect fees. The Town of Mansfield is not responsible for any damage to personal property during the rental period.

Waiver of Participant by Parent or Self: I hereby agree to release, discharge, and hold harmless the Town of Mansfield, its directors, officers, employees, agents, contractors, and/or volunteers from any and all liability or obligation that may occur during either my use or the use by my minor child of the Town's kayak(s) and or paddle board(s). This includes any injury or damage to the person or property of others, which I or my minor child causes or contributes to while using the kayaks, paddle boards, paddles, life jackets, or any other equipment rented from the Town. I understand that participation in any recreational or sport activity involves risk, and I further understand that the Town of Mansfield does not provide insurance for participants.
